- Elections
 - Maritza Mohammed
 - "This emergency meeting is about elections, last week I received an email from Jair from SCLD and the election timeline is starting this week. Motions

Motion Date: Monday, September 21st, 2020

Motion Pt 1: Be it resolved that Article 2 Section 2.b be updated to "The voting members of the Elections Committee shall be the Chief Returning Officer (CRO), two (2) impartial members of the New College Community, the Head, and a Residence Staff Representative"

Motivation: This update changes the language to include a wider range of eligible candidates for the elections committee including but not limited to Pond Road dons, NC Alumni, CRO's from other colleges and so on instead of exclusively non-returning members of council.

- Krista Lopiccolo
 - "It just changes the wording because what it was before was something like non-returning senior member of council, this just changes it so it doesn't necessarily have to be a senior member of council. It can be just anybody that's impartial so that would include Alumni's, Dons and anyone who is familiar with the community and the way that are college and council works that's not necessarily a senior non returning member of council so it just opens it up a little bit more. What the idea was as per the previous CRO's recommendation was that we use Dons as a part of our elections committee because they are fair impartial members and they are technically apart of our community. This would just broaden what the definition is for who can be an impartial member of the committee."

 - o "Do they have a vote?"
- Krista Lopicollo
 - "The people who have a vote would be myself, Filomena form the Head Office, Melanie from Pond and the 2 impartial people if this motion does pass which would either be if we can find Dons, Alumni or if it's someone from another college. Right now, I have one Don already selected and the other one I'm hoping it would be another Don but it might have to be someone from another college or an Alumni."

 - "When one-person reports demerit points or something like that, when situations do come up during elections. The elections committee is obligated to meet, and they must vote if they want these demerit points to be applied so that's when they will be voting...."





Motion Continued...

- Maritza Mohammed
 - "…As well, it's mainly their job to make sure the elections process is fair and that each candidate has a fair chance. When situations do come up, they have to vote if they deserve the demerit points or not also if candidates want to appeal their demerit points and get them taken away, they can send in a letter or statement and the elections committee would vote on that. As for the Chair that's the one that does not have a vote and everyone else apart of the committee does."

 - "In previous years, who were the 2 impartial voting members?"
- Maritza Mohammed
 - "In the past, they were members of council but didn't plan on running the following year but what the previous CRO saw that it wasn't 100% impartial and that they still had opinions on certain things so this year we decided to change it to 2 impartial people. We've seen other colleges do it, for example other colleges hire a CRO that isn't even apart of their college and has a different affiliation so we're trying to keep that same structure."

 - "Not to say that it couldn't be a non-returning member of council, but it just depends on the situation. Say that they've been on council for years and they already know everybody, there will be a little bit of a bias so the point of this is to take that bias out of it."

Motion: Be it resolved that article VI Section 13.4 "The number of signatures required in a nomination package during an online election will be reduced from 25 to 15" is added to the New College Bylaws.

Motivation: This change allows candidates to have an easier time gathering signatures as they will no longer be seeing each other in person and may not have large networks of people they know from New College (specifically first years but this can also occur in upper-year students as well)

 - "I just want to make it clear that this is exclusively for online elections so once we get back on campus it will go back to 25. The reason why I would like to change this is because it's been brought to my attention that people who are new in first year or don't have that network of people yet, it's harder for them to reach out to people to get over 25 signatures seeing as it's not like you're hanging out at New College, in the lounge, in the hallways and can see people and ask them regardless of whether you know them or not. Doing this online would be very hard so this is just to reduce those nerves and make it a little more attainable and comfortable for someone who doesn't have that network of people yet. For example, me being in 4th year and other upper year students wouldn't have that same issue but someone who is going for commuter rep or first year rep they might not have the same amount of people that they know from New College who can sign so this would make it more attainable solely for the online platform."
