Motion: Be it resolved that New College Council amends article 1.7 and adds "To be eligible, all candidates must not hold a full-time job throughout the summer unless the President and VP Operations decide otherwise" following point 3 in the bylaws.

Motivation:

Maritza Mohammed

O "Since the other motion passed, execs can hire one O-chair. When it comes to hiring one O-Chair, they can't hold a fulltime position. If it's two O-chairs we've allowed it in the past. If council is only hiring one O-Chair they should be able to have the full summer available for that."

Victoria Hanna

O "I think that this new by-law is not right because it's discriminating against the people who can apply. You don't know the person's personal situation and you're only going to get \$1000 for the month. This is not sustainable if you're a student trying to pay for your tuition, and I think it decreases the pool of applicants who might be able to do a really good job and we'd be missing out on that. I don't think it's fair to tell them that they aren't allowed and maybe giving them a chance to adjust in the first couple of weeks."

Blake Donovan

O "I just think it's hard to manage both a full-time job and running frosh. The O-chairs this year said having two people was needed because it would've been a lot of work for one person. If we had one person as O-chair and they had a full-time job, I feel like they wouldn't do as good of a job if they didn't have to work. I see where it's coming from if we had two people and one of them had a full-time job and the other didn't, it's a good medium."

Victoria Hanna

O "I kindly disagree with that because I believe the right person being someone who's dedicated towards the job is going to do a good job no matter what. I think that making sure the O-chairs can attend the weekly meetings is a must, but I don't think we should make it so that applicants can't hold a full-time job."

Shenali Don

O "Instead of putting it in the by-laws, we should put it in the application or in the interview and ask if they have a fulltime job. If they do ask how they'll manage it and go off that. I don't think it should be a set rule. We also must consider that not all fulltime jobs are 9am-5pm, some full-time jobs are during the weekends or evenings. In which they can work around both their job and being O-chair."

Josh Raghurai

O "To add onto that, when they do hire an O-chair, they do ask what their work schedule is like. I do believe in previous years, certain O-chairs who had a

O "If it's only one person and they have a full-time job, I don't see it being do-able but if you have two O-chairs at least one of them has to have a very open and flexible schedule because you never know what might pop-up and you have to spend an entire night to get it done for the next day."

Maritza Mohammed

O "Just because the last motion passed and now, we are able to only hire one O-chair. This motion should pass because if it's one person it will be a lot for them. In the application form, basing it off of the by-laws, one person can be hired or two. If we are able to hire only one O-chair now, it's just a time and availability thing."

Alexus Marticorena

O "I understand that it's a very heavy job, but I will say that some of us are able to be on council and have full-time jobs so I think it would be unfair to take that opportunity away from applicants. I understand that it's a heavy job and it should be made mandatory for them to be available throughout frosh week and when needed but also making them not be able to have a full-time job doesn't make sense to me because a lot of people can time-manage well. Therefore, I think it's unfair to say that the O-chairs shouldn't have a full-time job because if an opportunity comes up and they can't take it it's unfair to them."

Maritza Mohammed

O "In the By-law it says it's up to the President and the VP Operations so it would be by a case by case basis. For example, next year if three people apply, two of them aren't eligible and only one person is, and they want to work by themselves. When it comes to if they have a full-time job or if they don't, it depends on availability. If that person doesn't have a full-time job then the President and VP Operations can hire him but if it's two people who have a full-time job and they can work out availability then, it's also up to the President and VP Operations to make the decision as well."

Victoria Hanna

O "As we are all saying here, it's very dependent on the person. Whether it's two O-Chairs or one, I don't think it should be a by-law. It should be something that should be more discussed during the hiring process but again that shouldn't be the priority. The priority should be if the person is capable of doing the job and if they are then what they do on their free time shouldn't matter to council."

Shenali Don

O "The motion says it's up to the President and VP Operations. Why would we go through all that trouble when it can be asked during the hiring process and considered as a factor when evaluating different candidates. It doesn't need to by a by-law."

Krista Lopiccolo

O "Yes, it is something that impacts the hiring process but if you have that written as a

- Krista Lopiccolo
 - O "... the execs think that the O-Chair is capable of managing their time. If the execs think that they are not capable, it becomes personal when it doesn't need to be. If we just wrote it down as a part of the interview and weighted it as a heavy factor when determining who gets hired, I think it would be equally as effective without turning people off to the idea of applying in the first place."
- Nicholas McFarlene
 - O "A resolution we could express the kind of workload to the applicants if their applying by themselves and express that having a full-time job is a factor taken into account when hiring an O-Chair."
- Krista Lopiccolo
 - "We're all in agreeance that having a job is important to consider and it should be asked but I don't think it needs to be a by-law. Not making it a by-law doesn't mean that we throw it out the window and don't consider it. It just means that we're looking at it at a lower level as opposed to have it written in the by-laws."
- Shenali Don
 - O "This is just a quick point that some full-time jobs aren't demanding at all where you can do other work while on the job."
- Alexus Marticorena
 - O "I agree with the CRO, I also believe that it shouldn't be in the by-laws. For people privileged or fortunate enough to have the opportunity to take a position because they don't have work. By putting this by-law, we're excluding people that might not have the financial needs or the right funds which would make it unfair in my opinion. It would seem unfair to the members and would make it seem as though it is not an inclusive environment for people."

 - O "The only reason this motion is going in is because the other motion passed. If this motion fails when it comes to giving a transition meeting for the incoming Council members, we will bring up the point about availability being a factor."
