"The first point that was brought up was that we have no disaster plan. This was mainly about us having no President last year during the summer and the having a President cover the VP Finance position. In between that, the books weren't kept up to date and we didn't have a plan for COVID. What we talked about with Jair was that we would make a booklet, kind of like a guideline for VP Finances. Even though we do have a transition meeting, they still want us to write a book just in case the VP Finance refuses to do that meeting as so on. As for the courtesy account expenses. The VP Finance and I get an email with all the transactions that were taken out of the courtesy account. What they wanted up to do with that was print out the transactions and make sure they are accurate, but we didn't do that last year. As for classification of expenses, again, it was something where 2 years ago we named frosh week expenses, orientation week expenses. The year after that we named orientation week, frosh week for expense so all those things were all over the place. Last year we also bought merch, we never bought merch before, so it was a new category that we never budgeted before in the past, so it was a lot of those confusions. For essential and non-essential, last year was SCI so we didn't know we had to specify what each transaction was. If it was essential or non-essential so again, we got questions and comments about that. As for recording transactions, it was just about keeping up the books, when a cheque was deposited it wasn't updated in time. When the pandemic hit, a lot of things we're not recorded. Finally, for honoraria, we need to give you guys a T4-A slip because if it's over \$500, the government considers that more than just a gift of money so now we will set up T4 slips for those of you who will get more than \$500. We will get our levy once we complete this year's audit as well."
